The individual will be declared ineligible for RVA membership or USAV registration for two years starting from the date of the infraction.
	After event concludes	Individual will be declared ineligible for RVA membership or USAV registration for two years starting from the date of the infraction.
Third		Individual will be immediately declared ineligible for RVA membership or USAV registration for the remainder of her/his lifetime.
